#### 1. PARTIES

This Memorandum of Understanding (MoU) is entered into by and between:

- MSME Technology Centre, Durg (hereinafter referred to as "MSME-TC Durg"), located at Plot No: 2D, Sector-B, Borai Industrial Growth Centre, Rasmada, Dist-Durg (C.G)-491001.
- Swami Atmanand Govt. English Medium College, Durg (hereinafter referred to as "SAGEMMC Durg"), located at Dhanora, Dist-Durg, Chhattisgarh, 490001.

#### 2. PURPOSE

The purpose of this MoU is to establish a collaborative relationship between MSME-TC Durg and SAGEMMC Durg to enhance skill development, academic exchange, research, and consultancy. This collaboration aims to bridge the gap between industry and academia, fostering mutual understanding and growth.

#### 3. AREAS OF COLLABORATION

- e. **Resource Sharing:** Share academic resources, including libraries, laboratories, and other facilities, to support collaborative activities.

#### 4. RESPONSIBILITIES OF THE PARTIES

#### a. MSME-TC Durg:

- Provide access to training facilities and expertise for skill development programs.
- Support joint research initiatives and offer consultancy services where applicable.
- Facilitate the exchange of academic resources and information.

#### b. SAGEMMC Durg:

- Encourage faculty and students to participate in exchange programs and collaborative activities.

- Share academic resources and participate in joint research and consultancy projects.

#### 5. DURATION AND TERMINATION

- a. This MoU shall become effective upon signature by both parties and will remain in effect for a period of one (1) year.

- c. Either party may terminate this MoU by providing thirty (30) days' written notice to the other party.

#### 6. GENERAL PROVISIONS

- a. This MoU is a statement of intent to foster genuine and mutually beneficial collaboration. It is not legally binding and does not create any legal obligations or enforceable rights.
- b. Any specific projects or activities that involve the commitment of resources or funds will be outlined in separate agreements.
